Owners' responsibilities:

The below terms and conditions are in accordance with section 44 of the Animal Management (Cats and Dogs) Act 2008 (Qld) (*Registration obligation sets out the requirement for local government registration of certain cats and dogs in Queensland*) and Kowanyama Aboriginal Shire Council's Local Law No. 2 (Animal Management) 2015 and Subordinate Local Law No. 2 (Animal Management) 2015.

- Owners of dogs older than twelve weeks (3-months) are required to register their animals (unless a lawful exemption applies) with Council in the jurisdiction where the dog is ordinarily kept. Council further requires dog owners to promptly notify Council's Animal Management Department of any changes in ownership, the dog's death, or an address change.
- Registration must be maintained for each registration period as determined by Council.
- A maximum of two (2) dogs over the age of three (3) months may be kept on any premises. Approval from Council is **required** to keep more than two dogs on a property.
- Dogs three (3) months and over must be microchipped (unless exempt) and require dogs to bear their registration tag prescribed circumstances.
- If an unregistered dog is impounded while wandering at large and the owner cannot be identified, it may be held at Council's Pound for a minimum of five (5) days. If the owner is identified and notified, a minimum holding period of fourteen (14) days applies.
- When exercising with your dog in a public place, it must be under control by an appropriate leash, chain or rope.
- Dog owners are required to ensure that appropriate facilities exist on their property for securely confining the dog to the premises. Tethering is not considered an acceptable method for effective confinement within the premises.

Please note:

- Payment of relevant fees must be received by Council before new applications for registration can be processed. Please ensure you check Council's website for the correct Fees and Charges schedule.
- Under the Animal Management (Cats and Dogs) Act 2008 (Qld), the following dog breeds are classified as restricted dogs in Queensland: American Pit Bull Terrier or Pit Bull Terrier, Dogo Argentino, Fila Brasileiro (Brazilian Mastiff), Japanese Tosa, and Perro de Presa Canario (Presa Canario). Owners of these dogs must notify Council and comply with strict regulated-dog requirements. The acquisition, sale, supply, or breeding of restricted dogs is prohibited under the Act
